Paw Prints Pet Services Dog Walking Agreement

Paw Prints Pet Services offer a dog walking service to you on the following terms. References to 'Dog' are to the Customer's dog.

Paw Prints Pet Services will collect and walk the dog for the time agreed, on the agreed days from the customer's address, unless advised otherwise.

The Customer will either ensure that access is given to Paw Prints Pet Services to collect the Dog from the agreed address at the agreed times or give Paw Prints Pet Services a key to the place where the Dog is kept. Paw Prints Pet Services will use the key to collect and return the Dog and for no other purpose and will keep it safe, not let anyone else have it, nor copy it and will return it to the Customer on demand.

The Customer will supply suitable collars or harnesses and leads (and when necessary muzzles) for the Dog and any coats or other accessories which the Customer wishes to be used.

Access to your property must be straight forward, ie. keys should open doors easily or gates should be easy to open. If I am unable to gain access into your property after making every reasonable effort, you will still be charged for the walk. Where a dog flap is fitted, it is the owner's sole responsibility to ensure that the garden and its fences are secure. It is not Paw Prints Pet Services responsibility to check this before leaving your dog following a walk.

Paw Prints Pet Services reserves the right to walk other dogs at the same time, but the total number of dogs walked with one person at one time will not exceed two.

Clients must ensure that their requirements for the following week are e-mailed or text to us no later than Sunday evening and payments must be paid weekly.

At least 48 hours notice must be given, in order to cancel the walking service, otherwise you will be charged the dog walking fee.

The Customer will inform Paw Prints Pet Services fully of any characteristics of the Dog which needs to be known for handling and care of the Dog.

Paw Prints Pet Services holds insurance in respect of public liability, care custody control extension (liability to animals) and loss of keys.

Paw Prints Pet Services will inform the Customer of any incident or anything which Paw Prints Pet Services notices about the Dog, which as dog owners the Customer ought to know.

Paw Prints Pet Services will keep the Dog on a lead whenever out of the house, will take care so far as is practicable both that the Dog is not a nuisance or danger to any one, or any other animals, and itself. However, we cannot be held responsible for any loss, accident, injury or death caused to any animal whilst in our care.

Paw Prints Pet Services will supply a plastic bag and use it on all walks to remove the Dog's faeces and ensure that the Dog does not foul any public or private place.

The customer confirms that the Dog's vaccinations are up to date, including flea and worm treatments.

The Customer will provide Paw Prints Pet Services with contact details of its vet. In case of need Paw Prints Pet Services is authorised to refer the Dog to the named (or in emergency any other) vet for advice or treatment at the Customer's expense. The Customer undertakes to reimburse to Paw Prints Pet Services all expenses incurred under this clause. I am unable to walk any dog in season.
