Some were a challenge for all of us (I'm still awful at bouncing and catching the balls), but overall we had a very positive experience. Miss Nancy and Mickey did so many extra things. The graduation party was, literally, the icing on the cake. It was complete with cupcakes and soda, a present for Macie, games, decorations and even a mortarboard for pictures. Grandpa, Max and I had a great time.







From special presents, stickers and rewards, Macie always felt special here. I know much of the extra effort was Nancy's. Dr. Green is awesome and both ladies were incredibly patient with a wiggly girl who loves to talk...and her little brother who wanted to be included as much as possible.

While there were days and weeks when progress was hard to see, the results from the initial and final eye exams confirm the great improvement in Macie's visual abilities as a result of your program. The financial cost may seem high but your payment options are generous. The program demands much of the child and his/her family and final results are dependent on the amount of effort applied. When you realize the impact that the program could have on *all* of the child's future learning experiences, the actual value of Visual Therapy is priceless.
