These terms and conditions shall constitute a binding contract between Speckman and Credit Applicant. Neither party shall claim any amendment, modification, waiver or release from any of the provisions hereof unless the same is in writing and signed by both parties.
2. Payment Terms: If credit has not been arranged, payment must be made at the time of delivery. Statements will be sent at the end of the month, and payment is due 30 days from date of statement. A 2% discount (as shown on statement) may be taken if the statement is paid by the 10<sup>th</sup> day of the month following date of statement. Statements that remain unpaid beyond 30 days will bear **INTEREST** from date of statement at the rate of **ONE AND ONE-HALF PERCENT (1.5%)** per month, representing an **ANNUAL PERCENTAGE RATE OF EIGHTEEN PERCENT (18%)**. Where permissible by law, an account referred for collection is subject to reasonable attorney fees plus court costs. **RETURNED CHECKS WILL BE SUBJECT TO A \$30.00 FEE.**
3. Method of Payment: All payments must be made by cash, personal check, or certified check. At its sole discretion, Speckman may accept payments by credit card or debit card. All statements paid by credit card or debit card will be subject to a processing fee of **TWO PERCENT (2%)** of the payment.
4. Delinquent Accounts: Accounts having statements remaining unpaid 30 days from date of statement are considered delinquent, and the account may be canceled at Speckman's discretion.
