**DISCLOSURE FORMS FOR BACKGROUND CHECKS**  
**BOYS & GIRLS CLUBS OF WASHINGTON COUNTY**  
*Criminal History Checks*

As a condition of employment or volunteerism with Boys & Girls Clubs of Washington County, a successful criminal background investigation will be required. Current employees, applicants for employment, volunteers, or applicants for volunteer will be required to complete and sign appropriate disclosure and release documents for submission to appropriate law enforcement authorities in order to disclose the existence of a conviction for the following criminal offenses or a criminal offense which is equivalent to any of the following:

- All crimes against children, including child pornography, child molestation, child abuse, abandonment, child neglect, enticing a child into a motor vehicle, structure or isolated area and endangering the welfare of a child
- Crimes involving sexual assault, rape, criminal sexual contact or lewdness
- Murder, manslaughter or homicide
- Stalking, kidnapping and related offenses involving restraint, imprisonment, or criminal coercion
- Crimes involving assault with a weapon or an assault that results in bodily harm
- Sale of controlled substances
- Terrorist threats
- Cruelty to animals
- Any attempt or conspiracy to commit any of the crimes listed

Employees with convictions for the aforementioned criminal offenses will be immediately terminated. Applicants for employment with convictions for the aforementioned criminal offenses will not be considered for employment. Employees, volunteers, or applicants with convictions for other criminal offenses will be considered for retention or employment on a case-by-case basis by B&GCWC administration. B&GCWC reserves the right to require regular updates to background checks on all employees.

The Boys & Girls Club of Washington County follows closely the Wisconsin Regulations for Caregiver Background Checks.
