First and foremost, it is important that you confirm ministry availability and the time and date of the service as soon as possible to give the church and the minister time to prepare.

PLANNING THE SERVICE

Once the service time has been confirmed by the rentals co-ordinator, the minister will meet with you to lead you through planning the service. You will also have opportunity to meet with the church staff if you have any further questions concerning facility use.

Do you wish to have a funeral service (casket is present) or a memorial service (no casket)? When there is cremation, do you wish to have the urn present?

Is there a special picture that you would like to place on the communion table for the service?

What music and musicians would you like to have? What sort of music did your loved one like?

What scripture passages would you like read? Is there someone special you wish to do the reading?

Are there any other readings, poetry you would like read?

Do you wish to have a family member or friend share their memories of your loved one?

Is there anyone else you would like to participate in the service?

Do you wish to have a bulletin or program of the service?

What floral tributes would you like to have?

Do you wish to use the church hall for a reception?

Do you wish to have a "memory table" at the reception?

A list of suggestions of readings and hymns for your service can be provided by the ministerial staff.

Music

Music is an important part of a service. An organ and piano are located in the sanctuary. All arrangements for you to supply your own organist or pianist must meet with the approval of the church music director. All music must meet with the approval of the ministry staff.

We can assist you in booking soloists or instrumentalists, or you may wish to use a person of your own choice.

RECEPTION

After the service, many people wish to have a reception. This is helpful because it allows families and friends to gather and share stories and memories and offer support to one another. St. David's has large and small areas available to host receptions.
