*FOALS MUST BE CANADIAN REGISTERED.

The Canadian-Bred Declaration must be completed. Documentation of proof (invoices, export papers, etc.) may be requested pursuant to the above criteria. For purposes of participation in the Ontario Thoroughbred Improvement Program, there will be the designation of a "Registered Ontario-Bred" foal from 2008 forward. To be eligible, the foal must be born out of an "Ontario Resident Mare". All Ontario foaled horses in 2007 and prior years have been "grandfathered" into this program.

*To be recognized by the Program as an Ontario Thoroughbred Resident Mare, a broodmare must foal out in Ontario and must comply with specific criteria outlined on the Ontario Resident Mare Declaration.

This form must be completed for each mare, for each foaling year. Forms are year specific and can be found on the Alcohol Gaming Commission of Ontario, CTHS (Ontario Division) and CTHS (National Office) web sites.
