The Mountain-Ski Resort Ribniško Pohorje is located in the idyllic landscape of the western Pohorje Hills. The spatial positioning of the new tourist infrastructure is following the development of winter and summer tourism, including wellness tourism, spa tourism, congress tourism, cycle tourism, golfing tourism, adventure tourism, and agro-tourism. The diverse and varied mountainous landscape offers remarkable options for active holidays and relaxation in an idyllic mountainous landscape for all generations and types of guests as well as in all seasons.

The Mountain-Ski Resort Ribniško Pohorje encompasses all the modern trends of a skiing and wellness complex:

- The construction of the Pesnik circular cableway (KKS Pesnik) and a connecting way from the village of Ribnica na Pohorju to the existing Ribniška Koča Ski Centre on top of the Pohorje Hills;
- The construction of a hotel- and apartment complex in Ribnica na Pohorju;
- The installation of the Smolnik four-person chairlift;
- The development of three smaller apartment complexes next to the lifts at the Ribniško Pohorje: Pesnik, Smolnik, at the Ribniška Koča mountain lodge;
- The construction of two connecting four-person chairlifts to Hudi Kot - between the Ski Resort Ribniško Pohorje and the existing Kope Ski Centre (2 four-person chairlifts, six drag lifts);
