EXPLANATORY NOTE

To Zoning By-law No. 42-2019

Passed by the Council of the Municipal Corporation of the Township of Armour

Lands Affected: This By-law applies to all non-waterfront lots of record in Armour

Township zoned Rural (Ru) which front on a Township road.

By-Law Purpose: The purpose of this Amendment is to allow non-waterfront rural

garages to locate in the front yard as long as they are set back at

least 7.5 metres (25 feet) from the front lot line.

Official Plan: The proposed Zoning By-law amendment conforms with the

Regulations of the Armour Township Official Plan.

THE MUNICIPAL CORPORATION OF THE TOWNSHIP OF ARMOUR

ZONING BY-LAW NO. 42-2019

Being a By-law under the provisions of Sections 34 of the **Planning Act, R.S.O. 1990**, to amend Zoning By-law No. 27-95, as amended, of the Municipal Corporation of the Township of Armour with respect to provisions applying to garages on non-waterfront lands in the Rural (Ru) Zone which front on Township roads.

WHEREAS THE MUNICIPAL CORPORATION OF THE TOWNSHIP OF ARMOUR has reviewed Zoning By-law No. 27-95, as amended, and deems it advisable to amend same:

NOW THEREFORE THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE TOWNSHIP OF ARMOUR ENACTS as follows:

- 1. **THAT Subsection 5.1 "Accessory Uses and Buildings"** is hereby amended by deleting the wording of Subsection 5.1(f) and replacing it with the following:
 - "(f) Notwithstanding Subsection 5.1(b), a **detached garage** may be permitted within the required 15 metre (50 foot) front yard of a non-waterfront lot in the Rural (Ru) Zone provided it is located the greater of 7.5 metres (25 feet) from the front lot line or a 17.5 metre (58 foot) setback from the centre line of the travelled road."
- THAT this By-law shall come into force on the date it is passed by the Council of the Municipal Corporation of the Township of Armour, subject to the provisions of the Planning Act, R.S.O., 1990.
