Lands Affected: This By-law applies only to institutional and

certain recreational uses permitted in the Rural

Ru Zone.

By-Law Purpose: The purpose of the By-law is to permit

institutional and certain recreational uses, buildings and structures existing in the Rural Ru Zone at the date of passing of this By-law. Proposals to expand or establish new institutional or certain recreational uses in the Rural Ru Zone will require a zoning by-law

amendment.

ZONING BY-LAW NO. 37-2011

THE CORPORATION OF THE TOWNSHIP OF ARMOUR

Being a By-law under the provisions of Sections 34 of the **Planning Act, R.S.O. 1990**, to amend Zoning By-law No. 27-95 as amended of the Corporation of the Township of Armour, with respect to those lands within the Rural Ru Zone in the Township of Armour

WHEREAS THE CORPORATION OF THE TOWNSHIP OF ARMOUR has reviewed Zoning By-law No. 27-95, as amended, and deems it advisable to amend same:

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ARMOUR ENACTS as follows:

- 2. **THAT** Section 6.1(d) of Zoning By-law 27-95, as emended, is hereby amended by deleting the clause in its entirety and replacing it with the following:
 - "(d) (i) Institutional uses, buildings and structures; religious retreats, hunting lodges, private clubs, seasonal camp uses, buildings and structures; and public parks as existing on the date of passing of this by-law.
 - (ii) Redevelopment and residential intensification (see also Sections 5.2(b)(i) and (ii))"
- 3. **THAT** this By-law shall come into force on the date it is passed by the Council of the Corporation of the Township of Armour subject to the provisions of the **Planning Act, R.S.O. 1990.**
