Please see the minutes of the January Delegate Meeting on the noticeboard for a more comprehensive report but the issues directly relating to members at club level are:

- Transferring players must have a resume prepared and forwarded to transferring club
- Official web forms are to be used when submitting entries to district events, no emails or pieces of paper
- Delegate minutes will now be available on the web page. Secretaries to download and print a copy for the club noticeboard.
- Our district is the only district that has a Grade 5 pennant event.
- Change to conditions of play 2020 subs can now be skip
- Ex Servos have a new CEO. They have amalgamated under the new name Worrigee Sports and Bowls. Changing uniforms, upping fees and a new constitution which will take around 2 months to finalise. The new email address will be sent to clubs. Kerrie Way is to stay as president and they will only need a secretary and bowls organiser, no treasurer.

- Training for the new defibrillator Kerry Machon and Joanne Cummings have agreed (due to their medical backgrounds) to undertake training. In the advent of their being absent on bowling days, the management committee will view the demonstration as backup.
- On occasion when the wheelchair has been needed, it has been an issue to find it. It has been requested that there be a designated area to house the wheelchair. Lyn Newton to follow up.
- The next quarterly meeting will be held on Monday 20 April at 9am due to the pennant season.

- June Manning and June Hunter-Harchenko offered to run the raffles on each Tuesday and Thursday during pennants. The committee thanked them for this valuable contribution.
- The resignation of Annette Crabtree (to be included in next months correspondence) has been received. An EOI (expression of interest) will be asked for to fill this casual vacancy.
- Secretary Kerrie asked on behalf of some members, if the official club raffle machine could be used for raffle drawing so numbers could be seen on the screen when drawn. General discussion was to still use the current system (mobile phone number generator) but the raffles could be drawn after lunch to add a degree of excitement. This possibility to be trialled.
