Vice President's Report:

The VP spoke about the wrong bias tin whereby \$113 has been counted with a cheque being presented to the hospital after bowls today. All agreed that we should attempt to raise more money and rather than just wrong bias money going in, each bowling day, members are encouraged to place their small change into the tin or make some kind of donation whether they have had a wrong bias or not.

Bowls Coordinator:

The concept of a Monthly Champion has been further explored and the bowls coordinators plans to trial the idea and see if it is possible to collect the necessary data and determine a winner each month. Points will be awarded on social games only. Recording results in a spreadsheet is a possible solution, this will be investigated to determine the amount of work needed.

The yearly program is almost complete, approval to trial night games was requested and all agreed this was a good idea. The first trial will be the Men's Open Fours and will start on Friday 5th January.

The Tony Field memorial is to be played on Friday 24th November, finalisation of the details yet to be done as we are awaiting advice from Conjola regarding numbers. Conjola are not nominating any lady players. The proposed format will be a singles game, as well as pairs, triples and fours.

The bowls coordinator has requested we canvass interest in a start for Saturday bowls. Further work on this idea is needed.
