OPENING RECEPTION & CTANW Business

- Welcome from CTANW President Colleen Kuhn called the meeting to order at 9:15 am.
- Highlights & Celebrations President Kuhn reviewed highlights from the 2015-2016 year.
- The Year Ahead Our Goals Ryan Acker discussed the goals for the next year based on the strategic plan. He also encouraged members to send in any suggestions or ideas they have for improving CTANW.
- Minutes It was moved, second, passed unanimously to approve the minutes as presented.
- Financial Report Tom Dietz presented the financial report for review. It was moved, second, passed unanimously to approve the financials as presented.
- 2016-2017 Budget Tom Dietz presented the 2016-2017 budget for review. It was moved, second, passed unanimously to approve the 2016-2017 budget as presented.

PROFESSIONAL & COLLABORATIVE GROUPS – The membership divided into small workgroups to discuss their questions with other organizations.

- For-Profit Transportation Owners & Operators
 - Change is inevitable in NEMT. We need to prepare & participate.
 - Cost escalators
 - Pay to play
 - o Centralized Driver Pool
 - Certification Clearing House
 - Consistency between contractors
 - Non-emergent stretcher transport
 - Mental health
 - Proposed standards and best practices
 - o Get legislative approval and regulatory enforcement
 - Meet every 30 days

- Audience: all providers, CTANW members, brokers, contract holders, supported mobility population.
- Mobility Management & Travel Training Providers
 - Ability to provide training in different languages
 - Providing varied abilities training
 - Providing additional support to seniors
 - NWTT partnering with CTANW (certification program through Easter Seals)
 - Frequency: 2nd Monday of the 2nd month of the quarter, potential for email communication between meetings
 - o CTANW Support
 - Continued conferences and resources
 - Compile list of available mentors for new MM/TT programs (match.com for MM/TT)
 - Create library of available information (templates, resources)
 - Finding state level contacts
- Social Service Providers & Advocates
 - o Focus on individualized needs when considering system solutions
 - Professional personal development and ongoing support for providers (grief, boundaries, etc)
 - Partnerships between providers/systems/boundaries (transit, volunteers, users)
 - Need for immediate emergency services
 - Work on Human Services Transportation Planning to ensure active participation
 - Transportation is a social service
 - Find a way for real people to tell the stories
 - Consider how to report and what "language" is used (avoiding "government speak")
 - o Audience: users, decision makers, providers
- Transportation Managers & Directors (Nonprofit, Social Services, Public Transits)
 - Retention/recruitment
 - Paying living wage
 - o Balance customer needs with ability to provide resources (equipment/staff)
 - Solutions to fill gaps in service
 - Partnerships/creative collaboration
 - Balancing ADA regulations with the needs of the riders (length of boarding time)
 - Productivity vs good customer service vs cost
 - Value in meeting, potentially with WSTA Ops meetings.
 - Suggested being able to filter membership list on website by type of service (broker, provider, etc)
