As host of an official Chamber Latinos in Business event, we agree to the following terms:

### A. Space where the event will be held

- Space will accommodate 25-45 or more people comfortably.
- Space will be separated from regular business activity that would distract from the event.
- Space will be configured so that attendees can enter from only one place allowing for a reception table to be set up, so that all attendees can be greeted and signed in.
- There will be a place within the facility that 25-45 or more attendees can gather for the official presentations and can hear the speaker.
- Parking will be adequate to handle 25-45 or more people and will be clearly marked.
- Chamber will confirm Dignitaries, Chamber Board members as well as Ambassadors.

#### B. Entry to the Latinos in Business Mixer

- The Camarillo Chamber of Commerce will provide up to ten free guest tickets for your management, staff and clients. Please understand that all other attendees will be charged the standard Business After-Hours fee at the door.
- Host understands prices are to be set by the Chamber estimated at no charge for Chamber members and \$10.00 for non-members.

#### C. Food and beverage

 Host will serve "light" appetizers to all attendees, and if through a caterer or Restaurant, will use Chamber member restaurants and caterers (unless other arrangements are made through the Chamber staff). Host will also provide adequate serving utensils, plates, napkins, etc. Host will serve beverages to all attendees. - If you have a PA or sound system adequate for the anticipated crowd we would like to have it available to use.
