- Program and grant end dates
- Monthly Report:
 - ALL programs are required to submit a monthly enrollment report
 - Due by the <u>7th</u> of each month
 - Must be submitted in **PDF** format via email
 - Must include client level data



- 2015 PIT Count
 - Final numbers not yet published
 - Unsheltered homeless count continues to decrease
 - Veteran homeless count continues to decrease
- Chronically Homeless and Veteran placements (Jan-2012 to Jan-2015)
 - Chronic: 2,294 (avg. 62/month)
 - Veteran: 3,474 (avg. 94/month)
- Recidivism measurement




PSH Recidivism Rates

- New: Runaway and Homeless Youth Program (RHY)
 - ClientTrack workflows have been updated for RHY
 - HMIS participation deadline: April 15, 2015
- Proposed: old data archive and removal
 - Client records and associated transactions
 - Auto-removal: 7 years from last activity
- Rumor has it: ClientTrack15
 - Release by mid-2015
 - Integrated medical billing
