### **Chairperson's Message**




#### **Blow Molding Division Letter**



## Olefin Markets in Flux...Again



The Polyethylene market began the year with resin manufacturers seeking to implement a five cent increase which was originally announced effective December 1, 2010. However, after a year in which resin producers were able to expand profit margins and reportedly built an unwelcome amount of inventory late in the year, the market pushed back resulting in a flat January market settlement. February market prices ultimately split the nickel increase into an acceptance of three cents for February and two cents for March. Currently, most resin manufacturers are attempting to implement the six cent increase originally nominated for January 1, 2011 in addition to the remaining two from the nickel. One market leader has stated they seek to only implement the balance of the nickel in March and have decided to take a wait and see approach with the six, postponing the request until April 1. Further compounding the present and short term future market vision is the uncertainty of a new increase request by two prominent Polyethylene manufacturers that seek the full eight cents March 1. This new increase is in the amount of five cents and has not yet been addressed by the majority of their peers.


Why all the uncertainty? Several production issues have been experienced in the short calendar tick of 2011. Cold weather in production heavy asset states had slowed feedstock cracker rates. The availability of natural gas liquids to crackers was then impacted by a pipeline fire at a major clearing house. This fire caused some of the cracker operators that are capable of switching to heavier and more costly naphtha/oil based feeds. Good thing suppliers had built that inventory or it's likely more of these pennies could have been implemented. Also, the political unrest in the Middle East has increased the attractiveness of North American produced Polyethylene. The majority of Polyethylene made overseas is naphtha based where natural gas is the preferred base feed stock domestically. With the recent surge in oil prices the cost to produce overseas has increased thus permitting North American producers to raise the export market price. We all see a rise in domestic prices when the export or "floor price" increases.

It will be interesting to see what develops over the coming months in the Polyethylene market. There are several domestic world scale facilities due for scheduled maintenance, the oil market is bound to change one way or the other, civil uprisings continues overseas. In addition, we find ourselves in a bit of uncharted territory in analyzing the affects of the Pacific earthquake and tsunami. However, a few charts to help us understand where we've been so we may plan.

WTI Sweet Crude Oil & Ethylene Market Movement 2000 - Present






What a difference a month makes. Polypropylene prices rose seventeen cents in January 2011 after having risen three cents in December '10. February settled flat with a reported five cent reduction occurring in March. Holy Moly, when does one buy, likely, only when you have an order requiring Polypropylene? The reasons for the rapid escalation of Polypropylene pellet prices are directly tied to the run up in monomer prices. Unlike Polyethylene, Polypropylene, almost always moves in-step, up and down, with Propylene monomer market movements.

In terms of 2011, the sky-rocketing market for monomer can be attributed in part to unexpected domestic production issues which severely inhibited supply. In an already snug market, the need to satisfy the larger ethylene market due to the reasons referenced above further restricted the availability to the propylene market. As feed stock manufacturers continue to refine their business models and decrease costs, they have found it more profitable to use lighter feed stocks, natural gas vs. naphtha. Heavy feeds, however, provide a much higher yield of propylene monomer vs. ethylene so the evolution of industry has trended toward the production via lights limiting supply to the Polypropylene market.


Other factors limiting monomer supply to Polypropylene manufacturers include the fact that there are many more markets for this competitive feed stock than simply monomer straight to polymer, a few examples of these include asphalt, diesel, gasoline and residential fuels. Gasoline; likely a sore subject for each of us. Presently, the alkylation value of refinery grade propylene monomer has risen to sixty five cents per pound, up from fifty cents per pound. Cracker operators can in fact use catalyst systems and return this product into a value added sell-able back into fuel which actually increases fuel mileage by acting as an octane enhancer. So with a number of competitive markets, limited availability and surging oil markets, one might think the slight reduction seen in Polypropylene prices in March could very well be shorted lived. Presently, there are no nominations for price increase slated for April. Below are a few charts to aid in visualizing the Polypropylene landscape.
