What data do we collect?

FLARE GOVERNANCE collects the following data:

Personal identification information (Name, email address, phone number, etc.)

How do we collect your data?

You directly provide FLARE GOVERNANCE with most of the data we collect. We collect data and process data when you:

- Voluntarily complete a survey or provide feedback on our website or via email.
- Provide a one time or monthly donation through Donorbox payment method powered by Stripe.

For the purpose to proceed with payments we use DonorBox powered by Stripe. DonorBox is a service from Rebel Idealist LLC, 1885 Mission St, San Francisco, CA 94103. Your data will be sent to a server operated by Rebel Idealist LLC in the United States.

How will we use your data?

FLARE GOVERNANCE temporarily collects your data so that we can:

- Process your donation and manage your account
- Email you with updates about our events
- Measure our audience engagement

What are your data protection rights?

FLARE GOVERNANCE would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request FLARE GOVERNANCE for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that FLARE GOVERNANCE correct any information you believe is inaccurate. You also have the right to request FLARE GOVERNANCE to complete the information you believe is incomplete.

The right to erasure – You have the right to request that FLARE GOVERNANCE erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that FLARE GOVERNANCE restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to FLARE GOVERNANCE processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that FLARE GOVERNANCE transfer the data that we have collected to another organization, or directly to you, under certain conditions.
