CCHS Annual Meeting was held on Feb. 21, 2014, at Our Savior Lutheran Church.

The bi-annual election of board members was held and Debra Bullock, June Younger and JoAnn Stevenson were re-elected. They were elected to four-year terms.

Bullock received 39 votes, Younger received 37 votes, Stevenson received 28 votes and challenger Judy Tunis received 12 votes.

There were a large number of members present. A report of our last year was presented to the members. It was a very good meeting.



## A Moment in History... Commerce City Charter Delegate History

Prior to the Commerce City Charter, the city operated as a statutory city under the laws of the state of Colorado (State Legislature).

The city was in a category of being in a second-class city with statutes pertaining to them. If we had a problem, it was up to the Legislature to change the law and what was perceived as a problem in Commerce City didn't exist in other towns, so the reply was don't bother us.

The city had an elected city clerk and an elected city treasurer. Sybil Ratcliff was the city clerk and Casey Hayes was the treasurer

at a salary of \$100 per month.

The delegates were elected by the city residents on Nov. 4, 1969. They developed the proposed Charter and signed it on March 24, 1970. It was submitted to the vote of the people and an election was held on May 5, 1970.

Most of the delegates had full-time jobs and it was very difficult to juggle schedules; but, they took the necessary time off to complete this task. The individuals

represented a cross-section of the city and expressed many different viewpoints; but, came together with an excellent guideline for the common good of the people of Commerce City.

They took on a big commitment. First,



meeting once a week and then had to move it to twice a week. A third day was added to be able to complete the proposed charter.

They met at City

Hall which was located at 5291 East 60<sup>th</sup> Ave., currently the Adams 14 School District Administration Building. (The school district purchased the building from the City of Commerce City in 2007 when the city moved City Hall to it's new location at 7887 East 60<sup>th</sup> Ave.

The Charter Delegates were represented by Bob Gehler, the city attorney. He advised the delegates concerning all the legal ramifications and advised them in the philosophy and practical intent of the issues by researching several other city charters. He would then draft alternate provisions and take them back to the delegates to review and choose the provisions they preferred (one section at a time).

Other cities that had charters such as Thornton, Littleton, Golden, Westminster, Aurora and Englewood (to name a few) were a guideline for charter research for Commerce City.

Considering the proposed charter, the delegates took on the task of the immediate city challenges and looking into the needs of the people for the future. They wanted future city councils to have a document that would give them the tools to remedy problems and plan for a more productive and enjoyable lifestyle for the people of Commerce City.

As a result, a charter was written that has provided an effective and efficient form of government and led to becoming a Home Rule City.

Within the 50 years of this charter, it has been amended six times by the voters of Commerce City during city elections.

graduated from Union
High School in 1943 and
was drafted into the
Army in 1945. He was
assigned to D company,



310<sup>th</sup> Infantry Regiment of the 78<sup>th</sup> (Lightning) Division. He served during the occupation in Berlin, Germany, until October of 1946 and was one of the last two members of the regiment when it was deactivated after the war.

On returning home, he helped his father and uncle with the dairy and trained to become an auto mechanic. He opened his garage, Johnson Alignment and Brake Shop, on the family

property in 1955. The business flourished with many third and some fourth generation customers. He operated the business until retiring in 1989.

#### JACK SWEET JR.


Jack Joseph Sweet, Jr., 52, of Aurora died on Saturday, March 8, 2014. He was born Sept. 7, 1961.


