I/We understand and agree to the following rules concerning this exemption and further
agree to enforce such rules during the event:

1. Alcoholic beverages or cereal malt beverages will **NOT** be sold except as provided herein.
2. Persons under the age of 21 will **NOT** possess or consume alcoholic or cereal malt beverages.
3. The alcoholic consumption or cereal malt beverage consumption exemption will **NOT APPEAR** in any event advertising.
4. The exemption is for the **INSIDE** of the Municipal Hall only.
5. Persons or organizations allowing cereal malt beverages or alcoholic beverage to be consumed at the Municipal Hall will be held responsible for all violations of all laws, state and local, concerning possession and consumption by minors, and any other such laws and regulations concerning cereal malt beverages that from time to time be passed by the state or city.
6. Persons or organizations allowing cereal malt beverages or alcoholic beverage to be consumed at the Municipal Hall, may not sell cereal malt beverages or alcoholic beverages or mixes such as coke, 7up or any drink mix or ice used for mixing drinks or cups.
7. We understand that if there is a Cash Bar at the Anthony Municipal Hall during this event, it will be operated and managed by a Drinking Establishment licensed by the Alcoholic Beverage Control Division of the Kansas Department of Revenue and also having a Temporary Permit from the Alcoholic Beverage Control Division (unless the business has a catering license to sell liquor) for the Anthony Municipal Hall for the event. A copy of the License and the Permit must be provided with this application before approval by the Anthony City Commission.

We, whether one or more, agree to indemnify and save harmless the City of Anthony from all claims, liabilities and obligations by reason of our use of, operations or conduct on and/or occupancy of the Anthony Municipal Hall, including the provision and/or consumption of alcoholic beverages therein, and that in the event a judgment is entered against it, the City of Anthony is entitled in that amount from us, in addition to reasonable attorney fees.
