



# Privacy Policy

**Last updated: October 2018**

**Protecting your personal information is extremely important to Sheriff Hutton Village Market.**

The way we collect and share your information is equally important. The storage and management of information is done so privately and securely.

This policy tells you how we collect and process your personal information. Please take a few minutes to read it, and show it to anyone else connected to the policy.

## What is personal information?

When we talk about personal information we mean information about an individual that can identify them, like their name, address, e-mail address, telephone number and financial details. It can relate to customers, business contacts and suppliers. Any reference to “information” or “data” in this policy is a reference to personal information about a living individual.

# What information do we hold?

We may collect and process the following personal information about you:

## Where do we get our information from?

**Information you give us directly (when you fill in forms or contact us by phone, e-mail etc).**

**Information we collect about you or receive from other sources.** This could be information you provide to us electronically (through our website for example), information from a third party or from publicly available sources such as social media platforms. We do not use cookies.

## How do we use your information?

To carry out our responsibilities resulting from any agreements you've entered into with us (e.g. booking a market stall or supplying the village market with goods or services) and to provide you with the information needed to become a stallholder. If you are a supplier, your information will be used for us to communicate with you regarding your provision of services or goods.

As a stallholder, you have the opt in/out chance to allow your business details to appear on the Sheriff Hutton Village Market website. The sole purpose of this is to provide the general public with information regarding your products and the ability to make contact with you.

## Using your information in accordance with data protection laws

To use your personal information, we ask stallholders for their consent at the time of booking a trade pitch at the market. We'll rely on the following conditions:

**Providing our services to you:** We'll process your business information to carry out our responsibilities resulting from any agreements you've entered into with us in order for us to provide you with a market stall at Sheriff Hutton Village market

**Complying with applicable laws:** We may process your personal information to comply with any legal obligation we're subject to

**Consent:** We ask all stallholders to opt in/out at the time of booking a stall

## **Deleting your Personal Data**

We will automatically archive your personal details after 6 months of your business inactivity regarding the Sheriff Hutton Village Market. Inactivity means that the stallholder has withdrawn their opportunity to remain as a trader at Sheriff Hutton Village Market.

## **How long do we keep your information for?**

We'll keep your business contact information indefinitely for the purpose of the avoidance of duplicate future communication.

## **Who do we share your personal information with?**

We'll only disclose your business contact information on our web page and on social media where appropriate, and for marketing & advertising purposes. All other personal information will remain secure.

We will not disclose your personal information to third parties.

Unfortunately, sending information via e-mail is not completely secure; anything you send is done so at your own risk. Once received, we will secure your information in accordance with our security procedures and controls

## Your rights

You have rights under data protection law that relate to the way we process your personal data. More information on these rights can be found on the Information Commissioner's website.

1. The right to access the personal data that we hold about you.
2. The right to make us correct any inaccurate personal data we hold about you.
3. The right to make us erase any personal data we hold about you. This right will only apply (where for example):
  - we no longer need to use the personal data to achieve the purpose we collected it for
  - you withdraw your consent if we're using your personal data based on that consent
  - where you object to the way we use your data, and there is no overriding legitimate interest
4. The right to restrict our processing of the personal data we hold about you. This right will only apply where for example:
  - you dispute the accuracy of the personal data we hold
  - where we no longer need to use the personal data to achieve the purpose we collected it for, but you need the data for legal claims.
5. The right to object to our processing of personal data we hold about you
6. The right to withdraw your consent
