Unrestricted Goods

Unrestricted goods can be purchased online without the requirement for proof of an appropriate firearms license. Payment for unrestricted goods can be made using our merchant payment facilities at the checkout.

Restricted Goods

Restricted goods advertised on the Guns Plus Ammo website may include firearms, firearms components, ammunition, and knives. You must be eighteen years of age, or older to purchase restricted goods advertised on the Guns Plus Ammo website. Identification checks are conducted as part of the checkout process, and during either delivery, or collection of all restricted goods. Restricted goods that are advertised on the website are not able to be checked out in your cart – you may contact our store for purchase and collection/delivery.

Interstate Limitations

It is your responsibility to research the state laws where you live to ensure that any restricted item you think you may wish to purchase from us is lawful under your issued firearms license, and that the item is legal to be owned in your state. Any firearms sales whether generated through the website or in store require additional security measures. The user will be asked for firearms license details and an appropriate Permit to Acquire (PTA) as well as a nominated licensed firearms dealer of your choice, to affect the transfer if interstate. The firearm is then transferred between Guns Plus Ammo, and the nominated licensed firearms dealer, and you are required to collect the firearm from your nominated dealer. Your nominated firearms dealer will conduct additional checks, which may include your firearms license, a permit to acquire, or any other relevant documentation. Prior to any purchase, it is important to speak to your Dealer to confirm his, or her requirements of you.

Ammunition, Powder and Primers

You will be restricted from purchasing ammunition, powder & primers from the Guns Plus Ammo website. Ammunition, powder & primers requires dangerous goods couriers for transportation and a quote must be obtained for each individual order. For

this reason, it is not economical to allow ammunition purchases through the website. Please call to obtain a quote for the supply of ammunition.

Returns and Credits

No credits, refunds or exchanges of products will be issued without the production of the original sales voucher or tax invoice. Returned Goods must be in original undamaged factory packaging. Refunds processed will be less "our" postage cost not at the flat rate charged. Please Note: We are happy to process refunds in the form of a store credit.

Title

Title for the goods shall pass to the customer after the goods have been paid in full. Goods will not be shipped until full payment is received. There is no lay-by facility for online purchases.

Delivery and Shipping

Guns Plus Ammo uses several freight providers, we will endeavour to utilize the most cost-effective freight providers for your order. Shipping times may vary depending on your location, services used, availability of the goods ordered, these will be in accordance with the Post service provider. Guns Plus Ammo reserves the right to utilize any authorised postal service including but not limited to Australia Post. Return postal charges are at the purchaser's cost unless otherwise agreed upon by Guns Plus Ammo. Split Orders incur the (Flat Rate Charge) for each separate parcel sent. A tracking number may be provided by request, if available Returns, swaps or incorrect items must be received by "us" before a refund or replacement will be sent. All purchases must be paid in full before any products are posted.

Cancelled invoices

Any purchases cancelled shall be liable to a cancellation fee of 20% of the total purchase price which will be deducted from any refund payable on cancellation of the purchase

Lay-by (In Store Purchases Only)

ALL GOODS SOLD ON "LAY-BY" BASIS SHALL BE SUBJECT TO THE FOLLOWING CONDITIONS:

- 1. Minimum Deposit of 20% of the total purchase price shall be payable at the time of the original purchase.
- 2. Fortnightly instalments are to be approx. 20% of the total value.
- 3. The balance shall be payable by fortnightly instalments over a term of eight (8) weeks.

- 4. Any purchases cancelled shall be liable to a cancellation fee of 20% of the total purchase price which will be deducted from any refund payable on cancellation of the purchase. Any refund due will only be valid for cancellations made within the specified lay-by period.
- 5. Cancellations due to legal preclusion shall, on written official substantiation thereof, be refunded in full.
- 6. Goods partially or wholly paid for will be stored by us for a period of 16 weeks at no charge. Thereafter a storage fee of \$20 per month per firearm and \$20 per month per order will apply. Unclaimed goods or goods not purchased in accordance with these terms and conditions can be disposed of at Guns Plus Ammo Discretion after the said 16 weeks to recover storage and administration costs.

Property in any goods supplied by Guns Plus Ammo will not pass to the purchaser until such time as the goods have been paid for in full and all monies owed to Shooter's Delight paid in full.

Any items invoiced at discounted prices will revert to our standard list pricing if not paid for on or before the due date shown on the invoice.

Transfer of Property Rights

Property in any Firearm sold does not pass to the PURCHASER until presentation and finalisation of a Valid Permit to Acquire, all requirements of the Weapons Act 1990 have been satisfied and the goods have been paid for in full and all monies owed to Guns Plus Ammo paid in full.
