## Financial Report

Ian reported on the church finances for the year ending 31 August 2019 (the period relevant to the APCM April date).
An overall surplus of $£ 28190$ had been recorded for the year. lan highlighted a number of points from the results, e.g. payment of Preschool backdated rent, donations to the Garden of Remembrance project and the final contribution to the Diocesan payment from Putnoe. All Diocesan payments had been made on time. A copy of the audited accounts is available for inspection from the Church office.
Members approved the re-appointment of Collet Hulance as church auditors for the coming year. Thanks were again recorded to lan for continuing to look after the finances so diligently.

## Church Premises and adoption of Policies

All routine maintenance has continued and redecoration throughout the church premises has been carried out during the lock down period. All policies have been reviewed as necessary and are up to date.

## Safeguarding Policy Serious Incident Reporting

Charlie made reference to past shortcomings that have recently been acknowledged by the Church of England, and restated to all PCC members the responsibilities they hold as trustees. These are clearly set out in the meeting agenda and the Diocesan policies "Protecting all God's Children" and "Promoting a Safer Church".
Our Safeguarding Officer, Janet Day, ensures that up to date training and current DBS checks are in place for all PCC members.

Sam, as Area Dean, updated members on Deanery matters. It was report that all is running well. There is only one vacancy within the Deanery.
