### Apprentice Membership 1 - week days

#### Conditions:

- 1. Must have at least two private lessons (or one set of group lessons) with Chris, who must certify them capable to play 9 holes to a set standard which is less than 180 minutes, in 80 shots or less, and know the basic rules and etiquette before commencing membership application.
- 2. Playing times Monday 9-5pm. Wednesday 12-5pm, Thursday 12-5pm
- 3. Subscription £300 + lesson costs
- 4. No voting rights
- 5. Only available for a maximum of two years
- 6. Card for drinks/food £20.00
- 7. Normal interview procedure and then no other interview needed when applying for full membership

### Apprentice Membership 2 - weekends

Aim: To encourage players who have not yet reached handicap standard to work towards it by playing on our course at quiet times ultimately joining the club as full playing members.

#### Conditions:

- Must have at least two private lessons (or one set of group lessons) with Chris, who must certify them capable to play 9 holes to a set standard which is less than 180 minutes, in 80 shots or less, and know the basic rules and etiquette before commencing membership application.
- 2. Playing times Wednesday 6.30pm, Thursday 6.30pm, Saturday 3pm, Sundays 12noon if no event in the diary (they must go out within 60 minutes before any club match as per diary)
- 3. Subscription £300 + lesson costs
- 4. No voting rights
- 5. Only available for a maximum of two years
- 6. Card for drinks/food £20.00
- 7. Normal interview procedure and then no other interview needed when applying for full membership

### If anyone wants to convert their membership to full membership

- If during the year then the £300 would be deducted from their annual sub.
- If they wanted to pay by Membership Direct the monthly payments and the right to play would be synchronised.
