- We must be able to verify your identity, your income source, and/or employment.

Complete Application:

- Unless joint applicants are legally married, each must submit a separate application.
- Married couples may apply on ONE (the same) application.
- Please fill-out as much information as possible to expedite the processing of your application.

Identification:

- Please photograph and email your photo ID to the representative screening your application.
- If you are unable to photograph and email, please fax a clear copy to (570) 489-1851.

Prior Rental History:

- Please provide contact information / reference information so that we may contact your previous landlord / landlords. If for any reason you cannot provide this information, please explain why.

Income Source / Employment:

- It is extremely important for us to know if you will be able to afford your monthly rent payments. For that reason, we MUST be able to verify any source of income that you wish us to consider. Employment – please provide two (2) most recent pay stubs. Other income source – please explain or provide documentation showing proof of other income.

Credit Checks / Criminal Background Checks:

- All applicants are subject to a credit and background check. While your credit score and/or credit history is NOT the sole determining factor in our decision, we do run a report on every applicant.
- If we are able to accept an applicant with a "not so good" credit score, there may be a higher security deposit required. We DO look at other factors besides the credit score in making decisions.
- For your safety and the safety of all of our tenants, we do conduct a criminal background check and we are unable to rent to violent offenders and/or convicted felons.
