MEETING OF THE CITY COUNCIL OF

THE CITY OF HOMEWOOD, ALABAMA

September 14, 2020

The City Council of the City of Homewood, Alabama convened in Regular Session on Monday, September 14, 2020 at City Hall at 6:00 p.m.

The meeting was called to order by President Pro Tempore Wyatt at 6:11 p.m.

At this time, Mayor McBrayer addressed the Council and presented a Proclamation declaring September as Gynecological Cancer Awareness Month.
