

**MEETING OF THE CITY COUNCIL OF
THE CITY OF HOMEWOOD, ALABAMA**

November 27, 2017

The City Council of the City of Homewood, Alabama convened in Regular Session on Monday, November 27, 2017 at City Hall at 6:00 p.m.

The invocation was given by Melody Salter, City Clerk/Finance Director, after which the Pledge of Allegiance was given.

The meeting was called to order by President Limbaugh at 6:06 p.m.
