

G. SPECIAL SERVICES

1. Forwarding remains to another funeral home

This charge includes removal of remains, necessary services of staff, embalming, necessary authorizations, and local transportation to airport. This charge does not include visitation rights or ceremonies prior to forwarding of body.

- A. With minimum shipping container
- B. With casket selection from our Funeral Home (In addition to the cost of the casket)
- C. Air Tray

2. Receiving remains from another funeral home

This charge includes temporary shelter of remains, transportation of remains to cemetery and necessary service of staff. This charge does not include visitation, rites or ceremonies.

3. Immediate Burials

Our charge for an immediate burial, without any attendant rites or ceremonies, includes removal and shelter of remains, local transportation to the cemetery, necessary services of staff and authorizations.

- A. Immediate burial with merchandise provided by purchaser.
- B. Immediate burial with casket selected from our Funeral Home. (In addition to cost of casket)

4. Direct Cremations

Our charge for a direct cremation without any attendant rites or ceremonies includes removal of remains, local transportation to crematory, necessary service of staff, and authorization. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard of composition materials (with or without an outside covering). The containers we provide are Cardboard Cremation Container.

- A. Direct cremation with merchandise provided by purchaser
- B. Direct cremation with alternative container
- C. Direct cremation with casket selected from Funeral Home (In Addition to cost of casket)
- D. Additional charge per hour for staff services and/or use of facilities for partial ceremonies, body donations or other items not included in the about charges.
- E. Direct Cremation w/alternative container selected from Funeral Home.

ITEMIZED SELECTION

A. SERVICE OF FUNERAL DIRECTOR AND STAFF Our fee for the basic service of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family or responsible party; arrangement of funeral or other disposition; preparation and tilting of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notices; coordination with third party’s providing other portions of the funeral, e.g. cemetery, crematory and others. Also include in this charge are overhead expenses, secretarial and administrative cost, and equipment and inventory expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangement you select. (This fee is already included in our charges for direct cremation, immediate burials, and forwarding or receiving remains.

B. EMBALMING
Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

C. OTHER PREPARATION OF THE BODY
1. Reconstructive restoration when necessary.
