Additional Requirements

CLIA Certificate Waiver

A CLIA certification is required for facilities or practices that test clinical specimens for the purpose of diagnosis, treatment, or prevention of disease. If your facility only collects specimens to be sent out for testing at another facility, then a CLIA certification is not required; however, a CLIA waiver may be required in certain situations.

Billing Agency

Information regarding who is going to submit claims to payer sources on your behalf is required. If MNH is doing your billing, we will take care of this for you.

EFT Transfer Information

You will need to establish a business bank account and provide your credentialing specialist with banking information, such as, name, address, bank contact, routing and account number.



Ownership Information

If applying for Medicare or Medicaid, your credentialing specialist will need to know full name, DOB, address, place of birth, and SSN of each owner with >5% ownership.

Other Misc. Items

A few miscellaneous items you will need include your area(s) of specialty, date of incorporation, taxonomy code, type of organization, detailed education and training information, and hospital affiliations.






