You may choose only those items you desire. **However, any funeral arrangement you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and service you selected.

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for in full or in part, by or on behalf of the decedent.

**Basic Services of Funeral Home and Staff.....\$1995.00**

24 hour availability of funeral director and staff including, but not limited to, staff for initial request for services, counseling and supervision of all details for funeral service. Bookkeeping, accounting, general clerical to include filing necessary notices, certificates, authorizations and consents with proper authorities. Materials for compliance with Federal Trade Commission, Environmental Protection Agency and Occupational Safety and Health Administration Rules and Regulations.

*Note: This fee for our basic services will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains)*

**Removal.....\$485.00**

Licensed funeral director, assistant and necessary vehicle to call for remains within a 30 mile radius. Additional mileage is \$4.25 per mile.

**Embalming.....\$895.00**

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

**Use of Facilities and Staff**
