

The regular meeting of The Burk's Falls Council was held on Tuesday, December 17, 2019 at the Municipal Office at 6:00 pm.

Present: Reeve Cathy Still, Councillors, Lewis Hodgson, Jarvis Osborne, Lisa Morrison, Rex Smith; Staff: Nicky Kunkel, Clerk and Derek Smith, Public Works Foreman and Lacey Stevens, Recreation Coordinator.

The regular Council meeting was called to order at 6:00 pm

### **DECLARATION OF PECUNIARY INTEREST:**

Pecuniary Interest declared by: Councillor L. Hodgson regarding the renewal of the insurance program as resolution 2019-190.

### MINUTES

Resolution 2019-178 Moved by Jarvis Osborne – Seconded by Rex Smith That the Council for the Village of Burk's Falls approves the minutes of the Council meeting of November 19<sup>th</sup>, 2019 as circulated. Carried.

### **DELEGATIONS TO COUNCIL:**

1. Cindy Bourgignon attended the meeting to discuss sidewalk maintenance on Ryerson Crescent/Highway 520. There is a divide in ownership with the MTO saying it is up to the municipality and Council explained that as we don't have ownership of the land nor control on condition, if we maintained we would not be covered by insurance. There is no agreement between the province and the Village on clearing the snow from the sidewalk. It was agreed that Council will reach out to the MTO again in attempts to solving this re-occurring concern.

## **REPORTS TO COUNCIL:**

- 1. Public Works Foreman attended the meeting to discuss his department's quarterly operations report. He also spoke to the report to replace the GPS system and the report on purchasing a back up snowblower for the tractor. Resolutions were passed.
  - a. ECA application for the lagoons was also discussed at this time. Council received information regarding the application process from the Clerk and PWF. OCWA is preparing the application form and do not recommend submitting the application without performing studies to verify the amendment request. Staff believe the amendment to release two cells each season was the system design in 1973 and no studies are required as the new Certificate of Approval for the Lagoons has a typo which needs to be corrected only. Council agreed to submit the application prior to the studies, if they are required.
- Recreation Coordinator attended the meeting to discuss the report on the Recreation Action Plan Implementation and the activities completed to date. She also presented the 2020 Recreation Guide to Council which outlines all the activities planned for the following year and the dates.
  - a. The point of sale report was also presented and reviewed. Council agreed to obtaining this new service and device for all municipal payments in 2020.
- 3. The Waste Management Report on the affects of the Producer Responsibility for Recycling was received. This include a recap of other reports as well. There is still no date for the full switch over, but each section of recycling is being looked at separately and continues to be worked on. This will affect the landfill site at each stage.
- 4. Council received the report from the Almaguin Highlands Health Centre Manager and agreed to investigate opportunities and next stages for a Nurse Practitioner Practice at the Centre. Once the steps are in place and there is positive action an architect can be engaged to redesign space in the medical building for the NP Practice. A resolution was adopted.
- 5. Council received the report from the Treasurer on the Benefit comparison discussed at the November meeting. The two companies were very close when broken down to cost per hour (as employees are compensated) but the amount of coverage is better with Mosey and Mosey therefore, Council agreed to remain with Mosey and Mosey.
- 6. The Fire Chief's Report was received.
- The Waste Management Report for December was received by Council. It was noted that Burk's Falls residents were less than 3% of all waste deposited at the Landfill Site in 2019.



## **ITEMS FOR DISCUSSION:**

- 1. Council reviewed the correspondence from the Township of Armour regarding using the FIR for 2018 as the benchmark for costing a regional fire department. Council agreed in principal to the formula and Mayor Still will continue to attend all meetings regarding establishing a regional fire department.
- Council received the Memorandum for legal opinion for the proposed amendments to the Lakeland Shareholders agreement and they agree with recommendations as outlined. Mayor Still will attend the next meeting to express Council's position at the next shareholders meeting.
- 3. Council received the letter from the DPSSSAB regarding a district wide Ontario Health Team. Mayor Still and the Clerk reviewed the white board with all of Council to explain there are several options available and it is still unknown where Burk's Falls fits in with Muskoka Algonquin and West Parry Sound. Staff are continuing to investigate opportunities and do not want to eliminate any option at this time. Almaguin Highlands Health Centre Committee has also applied for a standalone health team that is still be considered by the Province.
