

THE VILLAGE OF BURK'S FALLS COUNCIL MEETING MINUTES November 24, 2020

The regular meeting of The Burk's Falls Council was held on Tuesday, November 24, 2020 in Council Chambers at 6:00 pm. Also available to public by Zoom.

Present: Mayor Cathy Still, Councillors, Lisa Morrison, Jarvis Osborne, Rex Smith, John Wilson; Staff: Nicky Kunkel, Clerk; Graham Smith, Arena Manager (via Zoom).

MINUTES

Resolution 2020-185 Moved by Lisa Morrison - Seconded by John Wilson That the Council for the Village of Burk's Falls hereby adopts the minutes of the regular Council meeting of October 27, 2020 as circulated. Carried.

DELEGATIONS TO COUNCIL None.

REPORTS TO COUNCIL:

1. Department Report: Arena Manager Graham Smith presented his report as submitted. Also discussed at this time was the report on the Ice Surface Installation. The Manager presented an update on the hours for community rentals which are below 10 at this time. He stressed that we have been reaching out trying to get more hours but there is no feedback or new rentals. Other local arenas are doing okay but still not at regular rentals so there is capacity locally. There are several groups who would use the facility with no ice as they are not able to operate in school gyms as they are closed. Council reviewed the three budgets prepared for each scenario: ice, no ice (no rentals), no ice (rentals). It was determined that the budget with no ice but community rentals was the best scenario as it would allow for more community use of the facility. Council and staff did ensure that the plan is to have ice in for the summer and fall of 2021, just not January to March as it would mean a unnecessary loss of \$38,000 and less accommodation to non-ice community use. A resolution was passed.

ITEMS FOR DISCUSSION:

- 1. Eastholme Ventilation Project was deferred as information was not available for the meeting.
- 2. Council discussed the December schedule. The traditional Christmas dinner was cancelled. A resolution was passed below for the regular year end Christmas items.
- 3. Council received the letter from the Integrity Commissioner stating the circumstances that Councillor Wilson would be in conflict when discussing Fire Department matters. In general, he is not in Conflict for budget or operations except when only he has benefit.
- 4. Council received the letter from Chairperson of the Almaguin Highlands Health Care Committee Rod Ward seeking the AHHC Boardroom be dedicated and named the Bruce Campbell Boardroom. A resolution was passed.
- 5. Council received the letter from the Santa Claus Parade Committee requesting financial support for Lighting/Decorating Contest. A resolution was passed.
- 6. Council received the email regarding Armstrong Bridge Project explaining the expected traffic delays for jacking the bridge. Signs have been made and will be posted for advance notice to the public as well as posted on the website and social media. Delays are expected for three weeks but just 15-30 minutes at a time and between the hours of 9:00 am and 2:00 pm when possible.

AND WHEREAS COVID restriction are expected to lessen in the 2nd quarter of 2021 due to a vaccine so summer and fall ice programs will continue as normal starting in July of 2021;

WHEREAS Council committed to investigating the establishment of a Regional Fire Department with the municipalities of Perry, Kearney, McMurrich Monteith, Magnetawan and the Burk's Falls Department; and

WHEREAS the goal of creating a Regional Fire Department is to ensure all responding fire fighters in all departments have the same training, that Fire Department purchases be focused based on response and streamlined to reduce duplication, and to reduce administration service duplication for policies and procedures that will in the end provide a unified emergency response to all municipalities; and

WHEREAS there has been general acknowledgement of the significant benefits gained from the efforts of our current regional training officer; and

WHEREAS it has been demonstrated that a cost sharing formula based on weighted assessment places an unfair contribution burden on the larger funding partners; and

WHEREAS it has been demonstrated that a cost sharing formula based on population and/or households places an unfair contribution burden on the smaller funding partners; and

WHEREAS it has been demonstrated that cost sharing with the current training cost formula, being equal division but between 7 municipalities indicates an unfair contribution of 4 municipalities who each support one Fire Department while the other three municipalities share in the cost of one Fire Department; and

WHEREAS should a cost sharing agreement not be reached for regional training each Fire Department would provide the mandatory training service at their own costs that closely resembles the cost of the current formula; and

WHEREAS it can be argued that there is not completely fair and equitable cost sharing formula for all partners for the provision of training or regional fire services.

NOW THEREFORE be it resolved that Council for the Village of Burk's Falls agrees that we renew the training officer agreement under the existing formula for a period of three years. Carried
