Release of Liability and Medical Release Form

Teen Nights are intended to be fun evenings for 6th graders and up where they can hang out, eat food, and build meaningful relationships in a safe and controlled environment.

Expectations:

- Boys & Girls Club staff work hard to provide members with a safe and fun atmosphere where they feel welcome and respected. In turn, we expect members to be respectful towards staff.
- We offer controlled access to the Club, meaning that all members must sign in and out at the main entrance. Teen night members may choose to check-in and out at their discretion, and it is their responsibility to communicate with parents or guardians about their whereabouts.
- All members are provided with a meal during Teen Nights. We ask that members keep their food and drink in designated food areas, and that they clear plates in the trash before returning them to the kitchen for cleaning.
- Teen Nights offer fun and engaging activities as well as movie nights intended for everyone. We ask that members help to maintain an inclusive atmosphere and follow rules, instructions and expectations as given by staff.
- We respectfully request that members refrain from using social media while at Club and keep cell phone use to a minimum and only when connecting with parents or guardians.
- We work hard to provide a safe, clean and fun space for all our Club members, we ask that you respect our building and facilities and clean up after yourselves.

Please remember that attending Teen Night is a privilege. Failure to abide by Club rules and policies and/or inappropriate behavior can result in a call to parents and being asked to leave Teen Night.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and has significant person-to-person spread. As a result, federal, state, and local governments and federal and state health agencies have recommended social distancing measures and have, in many locations, required ongoing prohibitions on the congregation of groups of people of various sizes.

Boys & Girls Club of Carbon County ("Club") has put in place preventative measures to reduce the spread of COVID-19. However, the Club cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending the Club could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the Club and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Club may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the Club or participation in Club programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Club, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club program.
