### Sherman Imler wins Social Security Disability

Sherman Imler is the spouse of Lisa Imler, one of our members. Sherman has been trying to win his social security disability benefits since 2002. He recently received the good news. He was approved for disability benefits dating back to 2002.

The decision is based on the following "severe impairments: degenerative disc disease of the lumbosacral spine and mold exposure manifesting as chronic bronchitis, diverticulitis, diverticulosis, colitis, myositis, chronic pain, and chronic fatigue (20 CFR 404.1520(c) and 416.920(c))."

#### Indoor factors affect childhood asthma rates

This study was conducted by the Center for Environmental Health, Institute of Epidemiology, in Munich, Germany.

"Asthma has become the most common, childhood chronic disease in the industrialized world, and it is also increasing in developing regions. There are huge differences in the prevalence of childhood asthma across countries and continents, and there is no doubt that the prevalence of asthma was strongly increasing during the past decades worldwide."

## Mold Suits Seek Millions in Damages

Suffolk Public Schools is facing new allegations of mold in the schools.

The parents of an elementary school student who formerly attended Southwestern Elementary School are requesting \$7.85 million in damages after their son suffered numerous symptoms ailments that, the suit alleges, were diagnosed as a reaction to mold.

Meanwhile, a former fourth-grade teacher has renewed a lawsuit she originally filed last year alleging she suffered severe symptoms of mold allergy while employed at Booker T. Washington Elementary School.

## Meeting with Senator Kean

John McBride met with New Jersey Senator Tom Kean on September 24. After hearing John's comments and recommendations, Senator Kean decided to focus his attention on the content of legislation that John proposed.

The Senator asked several questions and wanted to understand the details. He agreed to draft a Bill within the next 30 days, and he said he would ask John to review the proposed Bill before it is presented.

John's proposed legislation covers many key points, including the following:

- Emergency housing and evacuation
- Mandated testing and remediation
- Empowers government agencies to act
- Includes mold disclosures for rental properties
- Avoids setting safe levels and bases action on size of area affected and impact on occupant health
