

EN60 x 12:

Is a roundsling, green color, 5,300 lbs. vertical, 7/8" relaxed body width, 12' long

EN120 x 18:

Is a roundsling, tan color, 10,600 lbs. vertical, 1-1/8" relaxed body width, 18' long
