RELOCATION GUIDE FOR LAVA HOT SPRINGS, IDAHO

HISTORY

Lava Hot Springs is a community rich in western history. The abundance of natural resources in the region, such as the odor-free mineral hot springs, plentiful wildlife, and water supplies has attracted many to the area.

Before settlers discovered the natural hot waters of Lava, the proud Indian nation of the Bannock-Shoshone Tribes gathered at the original site of the mineral springs to bathe, rest, and worship the Great Spirit. Trappers and explores were the first white men to discover the hot mineral springs. Bob Dempsey, a squaw man, was the best known fur trapper to settle in the area. In the 1880's, the first white settlement, Dempsey, was a small farming community named after this well-known trapper. The first permanent white settler was Charlie Potter.

The Oregon Shortline Railroad that reached Montpelier in 1882 came through this valley about a year later. The present town site of Lava was homesteaded in 1890 by John Hall; he filed the plat in 1911 under the name of "Hall City". On July 24, 1915 the village was incorporated and named Lava Hot Springs. Every year we celebrate the birth of the city with a parade and a fireworks display off the cliff on the mountain overlooking the community.

In 1936 a fire broke out in town destroying one entire city block. In the years 1962-63 the pools and many private businesses suffered extensive flood damage from the Portneuf River. The citizens of Lava Hot Springs have maintained the dauntless spirit of their pioneer ancestors.

QUALITY OF LIFE

Lava Hot Springs is a small, picturesque tourist town nestled in the Rocky Mountains. The Portneuf River winds its way lazily through the center of the valley. Here lies our quiet, peaceful community. Lava has a friendly neighborhood feeling where the grocery clerks know your name, and you know theirs. Our schools are high quality and not crowded. Lava is truly one of the best small towns in America. Lava Hot Springs is certified by the Idaho Department of Commerce as a Gem Community.

Our residents have a strong sense of community and take pride in the town and its historical heritage. There are about 481 people that live within the city limits, while about another 500 live within 5 miles of the city.

The most constant thing about Lava is the hot water, which stays about 110 degrees summer, fall, winter, and spring. Vacationers enjoy the hot pools, Olympic-size swimming pool and float the Portneuf River. In addition there is a nine-hole golf course near town, various picnic sites, fishing ponds, and city parks to enjoy.

Lava is centrally located to the larger communities of Pocatello, Idaho Falls, Logan, UT and 2 hours to Salt Lake City. It's also 2½ hours to Jackson Hole, WY, and 3½ hours to Yellowstone National Park along the scenic route. Lava Hot Springs provides small town living with easy access to big town amenities when you want them.

Located along the Portneuf River, the town offers a central location to a large array of outdoor recreation with the Caribou National Forest and numerous other public lands and reservoirs in close proximity. Rich is history and scenic beauty, Lava is worth visiting and is a wonderful place to live. There is plenty of room to grow for family and new business.

CITY GOVERNMENT

The City of Lava Hot Springs has a mayor-council form of government with city elected officials working on a volunteer basis. Elected officials serve four-year terms. Regular City Council meetings are held on the second Thursday of each month of the year beginning at 5:30 p.m.

LAND USE - ZONING CLASSIFICATIONS

Lava Hot Springs has a zoning ordinance in place, last updated in 1983. The following is a brief description of each land use type within the city's ordinance. You can move down the scale, but not up the scale: e.g. R can be built in C, but C can't be put in R without zoning change.

- Residential 2 This combined residential zone is to provide medium density residential development well designed and properly located in the community pattern adjacent to shopping, recreation, cultural and other community facilities. Uses in this zone include single-family dwelling; home occupation; schools; churches; two-family and multi-family dwellings; and accessory uses.
- Residential 3 Provides for medium to high density residential development. This type of zoning pattern is intended to create transition area and buffer zones between commercial areas and low density residential development. It is also intended to permit higher density activities adjacent to more intensive community use areas. Uses in this zone include those uses allowed in the R-2 zone; multiple-family dwellings; boarding and rooming house; convalescent home; nursing home; rest home; elderly housing; hospital; club and lodge of a service and fraternal character; and nursery school.
- Commercial 1 Provides distinct zones regulated to provide local commercial service needs and to restrict incompatible uses which may be better located in community or highway oriented shopping areas due to the size of the shopping center location within the community, and residential neighborhood areas being served in other factors. Uses allowed included retail stores, personal service shops, banks, offices, hotels, motels, restaurants; clinics; commercial and private off-street parking lots; nursery schools, school for students of art, dramatics, dancing, music, business or secretarial work; government or public utility facilities of a non-industrial character; indoor theater, mortuaries; automobile service station; boarding and rooming houses; radio, television and FM broadcasting stations; signs including outdoor advertising; and accessory uses.
- Commercial 2 Provides a distinct zone regulated to fulfill general shopping center retail needs and travel or highway related service requirements within the community. Uses in this zone included those uses allowed in the C-1 Zone, automobile sales lot surface; automobile sales and service; trailer sales and rental; club and lodge; bowling alley, dance hall or similar commercial establishment as for public gathering and recreational use; travel-trailer park; taverns and lounges; and accessory uses.

UTILITIES

Lava's electric needs are served by Rocky Mountain Power Company, while natural gas is supplied by Intermountain Gas Company. Adequate capacity presently exists for both electricity and natural gas. CenturyLink provides telephone service and Independent Cable Services (a.k.a. Direct Communications) provides cable TV service.

Water is supplied by the City of Lava Hot Springs. The system's capacity and supply are adequate to meet the community's expected growth for several years. In order to ensure that the City of Lava is prepared for economic growth well into the future, the city drilled a new well in 1992. The city has a sanitary sewer system. The city is currently in the process of updating its sewer system, which will be adequate to meet the expected growth for several years. Fees for sewer and water hookup will be per ordinance.

United States Post Office 208-776-5680, **NOTE**: Not all residents within the city limits have a PO Box, and not all residents outside of the city limits have rural delivery. Please visit the Post Office to determine if you will need a PO Box or if your mail will be on the rural routes.

WATER SERVICE

1. Single Occupant - Standard Meter

The Base water Rate for a single City standard water meter is \$20.00 per month. This rate includes the first 5,000 gallons of water used.

The Volumetric Rate for any water consumed, above the initial 5,000 gallons is \$0.60 per 1,000 gallons of water.

The Total Monthly Water Rate is the total of the Base Water Rate and the Volumetric Rate as calculated above.

2. Single Occupant - Non Standard meter

The Non Standard Base Water Rate is based on the size of the existing or requested new water meter. This rate is determined by comparing the City's standard water meter orifice area to the water user's requested water meter orifice area. This comparison would yield an Adjustment Factor, which is then multiplied to the previously defined Base Water Rate. The Adjustment Factors and Rates are as follows:

- 3. Available Water Supply Fee \$5.00 per month.
- 4. The rates charged water users outside city limits shall be 1.5 times the rate charged users within the city limits.

SEWER HOOKUPS

Mandatory Hookup

Every parcel of land or premises within the boundaries of the City of Lava Hot Springs, improved for occupancy and occupied or used by any person or persons, shall be connected to the public sanitary sewer system provided that connection to the sanitary sewer system from inflow (storm drain) sources, outflow hot tub (natural baths) source or ground water infiltration into the sanitary sewer system shall neither be required or permitted.

Any special connections not covered by this schedule, including users outside the City, shall have connection fees set by the Mayor and City Council in each individual situation.

The connection fees are for the privilege of connecting the service to the city sewer. All charges associated with the laying of pipe from the homes or facilities to be served to said city mains shall be borne by the property owner. All such connections to the city's mains shall be properly designed and constructed in conformity with requirements specified by the city including asphalt repair.

LAVA HOT SPRINGS FIRE STATION

In 1991 the City of Lava Hot Springs contracted to provide the Rural Fire District with fire protection. Shortly thereafter they outgrew the station and began exploring avenues for expansion. In November 1995 the City purchased an existing warehouse on the west end of town. In 1996 a Community Block Grant was received to renovate the building. The total cost of the project was \$222,030 which included 67% of local match. The renovation was completed in January 1997 and the grand opening was in March 1997.

LAVA LIBRARY

The first library was organized in 1966 by a demonstration act, by the Congress of Idaho. A grant was set up by the state to provide a bookmobile, driver and library books for a mobile library for Southeast Bannock County. The city gave them a corner of City Hall, the Lions Club built shelving and the bookmobile brought about 100 books every month.

Several years later the Professional Women's Organization sponsored the Lava Library. A small office on Main Street was donated along with funds for utilities. Again the Lions Club built shelving, and the State Library furnished 500 books which were replaced every 6 months. Volunteers staffed the library.

In 1968 the citizens of Southeast Bannock County petitioned to form a library district, a board of directors was organized and a librarian was hired.

In 1972 the library moved to its present location at 33 East Main Street.

The library has been a real asset to our town. Since we are a resort town, the tourists appreciate the use of the library, as well as our many retirees, families, and other citizens.

SOUTH BANNOCK COUNTY HISTORICAL CENTER MUSEUM

THE "L" MOUNTAIN

One of Lava's unique features is the letter "L" that appears high on the mountain above the town. It was established during the 30's as a school project, when Lava had its own high school. The clearing of the brush and placing of the original rock forming the "L" was done by students. One can appreciate this effort only if they have hiked up the mountain to the "L".

The lights were added in the sixties when a group of High School Alumni collected money. Volunteers put them in place. It has been maintained by the City with the help of various volunteer groups such as the Boy Scouts, Lioness Club and Lions Club.

To appreciate the "L" at its best, it must be viewed at night. When approaching Lava from the west, it appears as magic and alerts the traveler of the approaching town.

TRANSPORTATION

Lava Hot Springs is located in Bannock County in southeast Idaho just 35 miles southeast of Pocatello, 50 miles west of the Wyoming border, and 150 miles north of Salt Lake City. Highway access to Lava Hot Springs is via Highway 30. Highway 30 intersects with Interstate Highway 15 just 11 miles west of Lava. Over 1.1 million vehicles traveled Highway 30 in 1993.

Air Service is provided at nearby Pocatello by Skywest and Horizon Air Lines, both providing several flights daily to Salt Lake City and Boise, respectively.

Lava Hot Springs Airport is located on a mesa 200 feet above the valley floor surrounded by mountains, 1.5 miles southwest of the City of Lava Hot Springs, adjacent to the golf course.
