## IMPORTANT INFORMATION

- ☐ **Closing dates** Grant applications are assessed 4 times a year, the closing dates for each round are: 31 March, 31 May, 31 August and 31 October. Late or incomplete applications will NOT be accepted. Late applications that are complete will be considered in the next round and incomplete applications will be returned to the applicant to complete.
- ☐ **Grant amounts** Amounts awarded are at the discretion of the trustees.
- ☐ **Grants** You may apply more than once in a year however the level of support may be determined by prior applications.
- ☐ **Payments** Applications are assessed quarterly. Approved applications can take up to 2 months before payment is made.
- ☐ **Withdraws** If you no longer require the grant prior to or after receiving the funding, you must notify Te Āti Hau Trust. If this does not occur, you may not be eligible for future grants.
- ☐ **Notification** You will be notified of the outcome as soon as practicable after the meeting.
- ☐ **Personal Details** This section provides key information about the applicant. The information is used to identify the applicant and to ensure we have the most up to date details.
- ☐ **Bank Details** Please provide a verified copy of your bank account. Here are some examples of what we accept:



- ☐ **Further information** Trustees may request further information on your application where clarity is sought
