What we collect

We may collect the following information:

- Full Name
- Contact information including contact number and email address
- Demographic information such as postcode, preferences and interests
- Next of Kin details
- Other information relevant to customer enquiries and/or offers.

What we do with the information gathered

We require this information to understand your needs and provide you with the most suitable service possible. The data we hold is also included the following reasons:

- Replying to enquires and questions relating to the services that Northern Dance Academy offers
- Invoicing for class fees
- Internal record keeping
- We may use the information we hold to improve our services
- We may periodically send promotional material about special offers or other information which we think you may find interesting using the email address or contact number that you have provided.

Security

We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect.

How we store our data

All data held by Northern Dance Academy Ltd is stored either electronically which is secured by password access only or as a hard copy that is stored in a secure, locked place.

All data will be stored for an additional 12 months if you decide you no longer require our services or attend Northern Dance Academy Ltd classes.

How we use cookies on our Website

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about webpage traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.

Overall, cookies help us provide you with a better online facility which enables us to monitor the pages you find most useful. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of the website.
