# 5. Harvestore Drive Sewer Improvements

Mike Holland presented the results of the September 1<sup>st</sup> bid opening as follows:

Mike Holland stated that Staff has reviewed the bid from Austin Tyler Construction and found everything to meet the bid requirements. Mike Holland stated that Austin Tyler is a known sewer and water contractor, who has completed many projects with Baxter & Woodman, although none to date for the District. Staff recommends acceptance of the bid from Austin Tyler Construction requests authorization to issue the Notice of Award.

President Collins moved to authorize the issuance of the Notice of Award to Austin Tyler Construction for the bid amount of \$2,885,404.00. Trustee Cosentino seconded.
