

## Airsoft Revolution 15- Waiver and Release of Liability

In consideration of being permitted to participate in any way in activities at Airsoft Revolution 15, including but not limited to, playing or otherwise using the premises, renting and operating equipment whether rented from or sanctioned by the arena, I acknowledge and agree that I fully understand:

(A) There are inherent risks and dangers in the use of Airsoft equipment, participation in Airsoft active play in the arena and electronic shoot range itself;

(B) My participation in such activities and/or use of such equipment, rented or otherwise, may result in injury or illness to me including but not limited to bruise, cuts, bodily injury, strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments that could cause serious disability;

(c) These risks and dangers may be caused by the negligence of the owners, employees, or agents of the arena; negligence on the part of other participants or others present, accidents, breaches of contract of safety rules, forces of nature or other causes; and

(d) By my participation in these activities and/or use of equipment, rented or otherwise, i hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, employees, or by any other person

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify the arena and its owners, agents, officers, employees and landlord from any and all claims, actions or and its for any losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of Airsoft equipment or my participation in Airsoft activities. I specifically understand that i am releasing, discharging and waiving any claims or actions that i may have presently or in the future, for any acts or other conduct by the owners, agents, officers or employees of the arena, including negligence.

### Medical Permission Authorization

if the participant is a minor, the undersigned parent or guardian hereby gives permission to authorize emergency medical treatment as may be deemed necessary for the child named below if injured in the course of participation in activities at the arena.

PHOTO OR RECORD ("AGREEMENT")**

In consideration for, and as a condition to, Participant (as identified below) being permitted to enter, access and use the property located at Airsoft Revolution 15 LLC Street, San Antonio, TX Zip Code.(the "Property") and participate in certain activities on, or located at, the Property (collectively, the "Activities"), the undersigned on his or her behalf, or on behalf of his or her child or legal dependent, as applicable, and on behalf of his, her or its heirs, legal representatives and assigns (collectively, the "Undersigned"), hereby acknowledges and agrees that Participant understands the nature of the Activities and is qualified, in good health, and in proper physical condition to participate in such Activities. The Undersigned hereby releases, waives, and discharges Airsoft Revolution15 LLC. I acknowledge that the participant is of age to play airsoft, which is 8 years old or older.

The Undersigned agrees that he or she will not, without the explicit written permission of Owner, take any photos or make any video or audio recordings of the interior of the Property or of any participants in Activities. All game types and verbiage used at Airsoft Revolution 15 LLC are property of Airsoft Revolution 15 LLC and are trademarked and or copyrighted by Airsoft Revolution 15 LLC. To copy or mimic these things will result in legal actions taken. The undersigned also agrees to photographs of him/her and the recordings of his/her voice maybe used for advertising, publicity, and commercial, or other business purposes. All pictures and video recordings taken at Airsoft Revolution 15 LLC are eligible to be used on Airsoft Revolution 15 LLC website and facebook page.

The Undersigned has read this Agreement, understands that the Undersigned has given up substantial rights by signing it and has signed it freely and without any inducement or assurance of any nature and intends that the execution and delivery of this Agreement shall constitute a complete and unconditional release of all liability to the greatest extent allowed by law and agrees that if any portion of this Agreement is held to be invalid the balance of this Agreement, notwithstanding, shall continue in full force effect.
