Chief Laux: Stats are in drop box. The stats are in for the last 3 years. In 2018 we took 81 reports, 2019-80 and in 2020-75. I expected it to be fewer reports with less on records. Call records highest with 3400 in 2018 3600 in 2019 and 3785 in 2020. Which shows we are out there a little more.

Laux: in regard to the Durango: I started reaching out today to Buds in Celina to look at both a V6 and a V8 to compare. I believe we had to purchase a V8 with hemi because it was the only option with AWD. I will report back on both options. Also, a letter was received from the Auglaize Co Sheriff about a donation to the Task Force which they do every 3-years. My recommendation is to contribute \$500 instead of \$1,000. Diller: I would be in favor of a \$500 donation. Laux: My hope is to contribute a little manpower wise from our department. Diller: I will approve the donation if council is fine with it. Wendel: You stated the calls were up, does that mean we assisted more? Laux: Everything is counted in that number: patrol, stops, phone calls. Wendel: Did the calls for assistance from the county go down? Laux: I will see if I can get you an answer on that. I am not sure, the way they report it is even if they pull up on one of our calls, they report it. It is hard to use their stats. I will check to see if they have a number for when they come when we are not available.

Kaup: Johan has agreed to take Tom Staugler's position on the Park Board for a five-year appointment. Post made a motion to accept the appointment of Johan Niekamp to the Park Board for a five-year term, this was seconded by Fiely. Vote all yes.

Staugler: nothing to report

Abels: nothing to report

Diller: Angie has given us the tax reports. 2020 didn't end up being a bad year from a financial standpoint for us. We ended up \$110,000 above last year with \$102,000 gain in the first 2 months and the last 10 months we were about even. We did come back to almost even being down just \$7,000 in withholdings. Overall, we came back pretty good. We still don't know what next year will be. We will keep monitoring

Projects: Nothing big to report. We are holding on the Broadway and Elm Street project.

Sludge press: The press is up and running, and is working out pretty well. There is a lot of tweaking and we need to figure out what to do with the sludge.

Monument Park. The light bases are poured. The poles are ordered and we expect delivery by February 15th.

Zoning: I will reach out to the planning commission this week to set up a meeting.

Tap Grant: We are working through the application which is due at the end of the month. It is mostly mapping numbers and a project description. Erin will have a resolution at the next meeting.

GIS Utility Mapping: We will have a training later this month.

Street Dept Position: We will put the press release out this week for the position. Applicants will have until January 20th to apply. Does anyone want to be involved with the position interviewing? Kaup: I certainly can be. Diller: It will entail a few interviews and probably final interviews.

OBWC Refunds: We received a check for \$18,000 in the mail last week as our portion of the 5 billion in refunds. That is a total of \$28,600 that we received back in 2020 in refunds. That is equivalent to five or six years of our current premiums. We appreciate the state doing that.
