
# FULL PAPER SUBMISSION GUIDELINES



# **AFRICAN TAX RESEARCH NETWORK (ATRN)**

### **GUIDELINES FOR THE SUBMISSION OF FULL-LENGTH PAPERS**

## 1. General guidelines

#### NO PAPERS BEYOND THE THEME AND SUB-THEMES WILL BE ACCEPTED

- Only FULL-LENGTH FINAL PAPERS will be accepted.
- Paper submissions must include two (02) documents:
  - 1. **Title page** should include:
    - Article Title
    - Full Name and Contact details (institution, postal address; telephone number, and email address) of the corresponding/presenting author
    - Full Names and Contact details (institution, postal address; telephone number, and email address) of all co-authors
    - Abstract (up to 150 words)
    - Acknowledgements
    - keywords and JEL codes.

## 2. Manuscript should include:

- Main text
- Indication of figures and tables with numbering, title and source
- References
- Appendices
- Manuscripts should be anonymous.
- Academic papers should preferably contain the following: Introduction; Research questions; Research objectives and/or hypotheses; Literature review; Research methodology; Results/Findings; Policy recommendations; and, Conclusions. Papers submitted will be double-blind peer reviewed by the ATRN Scientific Committee.
- Only ORIGINAL papers will be accepted (no papers with prior submission to any journals, working papers, or conferences)
- Plagiarised Paper submissions will be automatically disqualified and rejected

For papers accepted for presentation at the Congress, if more than one author is involved, at least one author must register for and attend the conference to present the paper. All conference attendees must register on the website.



## 2. Style guidelines

- Technical requirements:
  - o MS Word documents only. No PDF will be considered.
  - o Manuscripts are restricted to 25 pages/max 8000 words (including appendices and references)
  - o British English spelling and punctuation are preferred.
  - o Font: Times New Roman; Font size: 12; Spacing: 1.5 line spacing.
  - o Margins: 2.5 cm left margin and 2 cm top, bottom and right margins.
  - o Referencing technique: **APA** or **Harvard** styles of referencing only.
- Very important: All manuscripts should be proofread and edited before submission. The ATRN Secretariat will
  conduct a desk edit before all manuscripts are sent out to reviewers. Manuscripts will be automatically rejected
  if they do not respect the guidelines. Please ensure that technical and language standards of the final paper are
  acceptable.
