



# DES MOINES ARTS COMMISSION CALL FOR ARTISTS APPLICATION 2021 Virtual Music Sessions

## OVERVIEW

The Des Moines Arts Commission (DMAC) is hosting a free virtual music session for release in 2021 and is looking for musicians/bands to prerecord a live session at the Beach Park Event Centers Auditorium. Each session will be uploaded to select social media platforms and released on a future date free to the public.

## CRITERIA

All music performed must be original music. Marketing materials such as photography, artist bit, and two 5-minute instrumental recordings will be needed for advertisements, press releases, and any efforts in assisting with promotion of this free event will be required. Members of band must follow all current Covid-19 Health and Safety mandates, including wearing a facemask at all times unless singing or playing a wind instrument and performing a health screening before recording. Social distancing must be practiced at all times, even when not on stage. 6-10 feet of distance must be maintained at all times.

## COMMISSION

Each band/artist will be paid a stipend of \$1,500 for full performance, access to social media recordings, and a digital copy of recording post-editing. Access to a Green Room, water, and boxed meals will be provided. Checks will be issued by mail after recording, W-9 will be required at the time of contracting to issue payment.

## RECORDING DATE

This application is for recording dates on December 16, 2020 or December 17, 2020. Applications received will be in review for future recordings in 2021.
