#### RACCOON TRAPPING PRICING AND PROCEDURES

1. INITIAL SERVICE CHARGE \$255.00 INCLUDES THREE SERVICE CALLS TO HOME. FIRST SERVICE CALL WE WILL DO A THOROUGH INSPECTION TO LOCATE ALL OPENINGS. IF NO OPENINGS ARE FOUND OR THE CUSTOMER CHOOSES NOT TO TRAP ANIMALS, THE INSPECTION FEE OF \$140.00 WILL BE CHARGED. TRAPPING STARTS WITH THE PLACEMENT OF 2 RACCOON TRAPS SET AS CLOSE TO THE OPENING(S) AS POSSIBLE, THE TRAPS ARE USUALLY SITUATED ON THE ROOF SO THE CUSTOMER CAN EASILY CHECK THE TRAPS EVERY DAY FOR ANIMALS. TEMPORARY CLOSURE(S) ARE STAPLED OR TAPED OVER OPENING(S) FOUND DURING INSPECTION. RACCOONS CAN EASILY BREAK THROUGH TEMPORARY CLOSURES INDICATING ACTIVITY IF DISTURBED.

THE ILLINOIS DEPT. OF NATURAL RESOURCES REQUIRES THAT ALL WILDLIFE TRAPS MUST BE CHECKED ONCE A DAY. UNDER THIS SERVICE AGREEMENT THE HOMEOWNER WILL CHECK THE TRAPS EVERY MORNING BEFORE 9AM. THE HOMEOWNER OR PRE-ARRANGED CONTACT PERSON WILL CALL OR TEXT A-1 PEST CONTROL AT 847 433-3351 TO REPORT ON THE CONDITION OF THE TRAPS. EVEN IF TRAPS ARE EMPTY WE MUST KNOW. IF YOU DON'T RESPOND BY 9AM WE WILL TEXT YOU ON CONDITION OF TRAPS. IF THERE IS NO RESPONSE WE WILL HAVE TO DRIVE BY AND CHECK TRAPS. THIS IS A \$50.00 CHARGE, IF RACCOON(S) ARE IN TRAPS, THEN REGULAR CHARGES WILL APPLY.

2. SECOND TRIP, USUALLY REMOVE THE FIRST GROUP OF CAUGHT RACCOONS. TRAPS ARE RESET AND ANY TEMPORARY CLOSURE(S) THAT HAVE BEEN DISTURBED WILL BE REPLACED. TEMPORARY CLOSURE(S) THAT ARE UNDISTURBED FOR 3-5 DAYS ARE CONSIDERED INACTIVE AND CAN BE CLOSED.

3. THIRD TRIP OUT, COULD BE TO CLOSE OPENING(S), ONLY IF TEMPORARY CLOSURE(S) HAVE NOT BEEN DISTURBED FOR 3-5 DAYS, IN THIS CASE THE OPENING(S) WILL BE CLOSED AT THE PRE-ARRANGED PRICE. THIRD TRIP COULD ALSO BE TO REMOVE ANOTHER GROUP OF RACCOONS, IF SO TRAPS WILL BE RESET AND NEW TEMPORARY CLOSURE(S) WILL BE INSTALLED WHERE NEEDED. THIS PROCESS WILL REPEAT UNTIL THE TEMPORARY CLOSURE(S) HAVE NOT BEEN DISTURBED FOR 3-5 DAYS. EACH ADDITIONAL SERVICE CALL TO REMOVE RACCOON(S) WILL BE CHARGED AT \$85.00 ABOVE AND BEYOND THE INITIAL SERVICE CHARGE OF \$255.00.

4. TO START TRAPPING WE NEED TO RECIEVE A CHECK FOR \$255.00. WHEN TRAPPING IS DONE A DETAILED INVOICE WILL BE SENT DOCUMENTING ALL SERVICES AND CHARGES. THERE IS NO CHARGE FOR RESETTING TRAPS DUE TO SNOW, RAIN OR HIGH WINDS. WE CHARGE FOR THE INSPECTION, REMOVAL OF RACCOONS AND THE CLOSING OF OPENING(S) AT A PRE-ARRANGED PRICE. PLEASE INFORM US IF PLAN ON LEAVING TOWN OR ARE UNABLE TO CHECK TRAPS. PLEASE MONITOR TRAPS

AND CALL EVERY MORNING BEFORE 9AM. THIS INCLUDES SATURDAY AND SUNDAY.
