**PRICING AND PROCEDURES FOR TRAPPING SKUNKS**

**1. INITIAL SERVICE CHARGE OF \$335.00 INCLUDES 3 SERVICE CALLS TO THE HOME. FIRST SERVICE WE WILL DO A THOROUGH INSPECTION TO LOCATE ALL AREAS OF ACTIVITY. IF CUSTOMER CHOOSES NOT TO TRAP, THE INSPECTION FEE OF \$110.00 WILL BE CHARGED. TRAPPING STARTS BY PLACING A SPECIAL SKUNK TRAP AS CLOSE TO BURROW(S) OR OPENING(S) AS POSSIBLE. TEMPORARY CLOSURES ARE PLACED OVER BURROW(S) OR OPENING(S). ANIMALS CAN EASILY BREAK THROUGH TEMPORARY CLOSURE INDICATING ACTIVITY IF DISTURBED.**

**THE ILLINOIS DEPT. OF NATURAL RESOURCES REQUIRES THAT ALL WILDLIFE TRAPS MUST BE CHECKED ONCE A DAY. UNDER THIS SERVICE AGREEMENT THE HOMEOWNER WILL CHECK THE TRAPS EVERY MORNING BY 9AM. THE HOMEOWNER OR PRE-ARRANGED CONTACT PERSON WILL CALL OR TEXT A-1 PEST CONTROL AT 847 433-3351 TO REPORT ON THE CONDITION OF THE TRAPS. EVEN IF TRAPS ARE EMPTY WE MUST KNOW. IF YOU DON'T RESPOND BY 9AM WE WILL TEXT YOU ON CONDITION OF TRAPS. IF THERE IS NO RESPONSE WE WILL HAVE TO DRIVE BY AND CHECK TRAP. THE CHARGE FOR THIS SERVICE IS \$50.00, IF AN ANIMAL IS IN A TRAP, REGULAR PRICES WILL APPLY.**

**2. SECOND SERVICE CALL IS USUALLY TO REMOVE TRAPPED SKUNK. THAT ANIMAL WILL BE REMOVED AND ANOTHER TRAP WILL BE SET. TEMPORARY CLOSURES WILL BE REPLACED WHERE NEEDED. ANIMALS OTHER THAN SKUNKS WILL BE REMOVED AT \$70.00.**

**3. THIRD SERVICE CALL COULD BE TO CLOSE OPENING(S), ONLY IF TEMPORARY CLOSURE(S) HAS NOT BEEN DISTURBED FOR 3-5 DAYS AND AT A PRE-ARRANGED PRICE. THIRD TRIP COULD BE TO REMOVE ANOTHER SKUNK, IF SO TRAP WILL BE RESET AND NEW TEMPORARY CLOSURE(S) WILL BE INSTALLED. THIS PROCESS WILL REPEAT UNTIL THE TEMPORARY CLOSURES HAVE NOT BEEN DISTURBED FOR 3-5 DAYS. EACH ADDITIONAL PICK UP WILL BE \$125.00 ABOVE AND BEYOND THE INITIAL SERVICE CHARGE OF \$335.00**

**4. TO START TRAPPING WE NEED TO RECIEVE A CHECK FOR \$335.00. WHEN TRAPPING IS DONE A DETAILED INVOICE WILL BE SENT DOCUMENTING ALL SERVICES AND CHARGES. THERE IS NO CHARGE FOR RESETTING TRAPS DUE TO SNOW, RAIN, OR HIGH WINDS. WE CHARGE FOR THE INSPECTION, REMOVAL OF ANIMALS AND THE CLOSING OF OPENING(S) AT A PRE-ARRANGED PRICE. PLEASE INFORM US IF YOU PLAN TO LEAVE TOWN OR ARE UNABLE TO CHECK THE TRAPS. PLEASE MONITOR TRAPS AND CALL OR TEXT EVERY MORNING BEFORE 9AM THIS INCLUDES SATURDAY AND SUNDAY.**
