What is GDPR?

- GDPR is the new Data Protection law
- It is 88 pages long and brings the old law up to date with the 21st century
- It comes into affect on the 25th May 2018
- It covers the automated and structured processing of personal data.
- It covers a wider range of organisations both inside and outside the EU.
- Brexit is not a get out of jail free card

What are it's key points for small charities?

- GDPR – brings a new concept of Data Protection by design
- Transparency and accountability are at core of it's new principles
- Consent for the use of personal data
- Processing for a new purpose
- Rights of the Data Subject
- Data minimisation
- Appropriate storage systems

How could it affect your charity?

- You need to be prepared to be compliant with GDPR
- Ensure that anyone processing personal data for your organisation is also compliant as it is now your responsibility.
- You will need to ensure your consent procedures are updated
- Data can only be used for the original purpose it was intended

Key actions to be compliant

- Audit your data processing activities and conduct a gap analysis to identify actions
- Seek professional advice regarding exemptions
- Review consent mechanisms and implement appropriate systems for record both consent and withdrawal
- Update all of your information notices, particularly around children and parental consent.
- Make sure you notify the Information Commission

Other changes set to take place

- Privacy and Electronic Communications Regulations (PECR) changing to electronic Privacy Regulations (ePR)
- The Fundraising Preference Service – Linked to the Fundraising Regulator
- The charities (protection and social investment) Act 2016
- Fundraising Code of Practice - Linked to the Fundraising Regulator
