- Current State of Florida License (nurses)  
Experience in medical/surgical nursing
- Current State of FL Certificate (CNA, HHA)
- CPR Certified - Adult and Pediatrics
- Health clearance from communicable diseases
- Individual malpractice insurance
- Minimum of 3 references (we verify)
- Must conform to all high standards and policies of *A Nurses Registry*, exceeding state guidelines


