## **ON THE BEACH GENERAL LIABILITY INSURANCE**

This policy is for organizations who neither own nor lease their club quarters (paper clubs) and for organizations who do own or lease their quarters (or land) with Annual Revenue (including dues) which does not exceed \$50,000. The policy provides \$1,000,000 Bodily Injury and Property Damage Liability combined single limit & \$2,000,000 Aggregate including first dollar legal defense per occurrence.

## **WHO MAY PARTICIPATE**

This protection is available to participants in The David Agency Regatta Liability Insurance Program. The applicant organizations will become Named Insured with their own policy.

## **DESCRIPTION OF THE PROTECTION**

This insurance is designed to provide relief from lawsuits or judgments which may arise from incidents on land (not on the water). Host Liquor Liability is included in the protection. Land owners (not the insured) can be added as an "Additional Insured" for claims that are a direct result from the event.

## **EXCLUSION**

Any claim that results from kites as propulsion shall be excluded. See policy for standard exclusions.

## **PREMIUMS**

This policy carries a flat premium charge of \$400. An additional charge of \$53 is levied for each additional insured added to the policy. The premium applies from the date of acceptance of the application until 1/1/2021 with no pro-ration.

## **ENROLLMENT INFORMATION**

To obtain this protection, the organization must complete the Named Insured request form and send it, along with a check (payable to The David Agency), to The David Agency, 385 North York Road, Elmhurst, IL 60126. Coverage becomes effective the date the form and premium check are received at The David Agency office. Each organization that obtains this protection will be issued a policy.

## **TERRORISM RISK INSURANCE ACT**

It is required by Federal Law to offer Terrorism Risk Insurance. We give you the choice to Accept or Reject this coverage, which requires signature either way, and a premium charge if accepted.
