



In response to your enquiry addressed to Lloyd's, I enclose coverage details issued by us on 26th October 1990, regarding the above named insured.

The coverage was placed by us as Lloyd's Brokers, with certain Lloyd's Underwriters for the period twelve months at 23rd October 1990, for a policy limit of \$75,000 any one loss, subject to the Broad Form Policy Wording, and exclusions, a copy of which may be obtained from Instate Coastal Insurance Services, Inc., 101 South Kraemer Boulevard, Suite 120, Placentia, California.

The policy has been endorsed by addendum Nos. 2 and 4, copies of which are also enclosed.

Please note that the certificate and endorsements that you sent to Lloyd's are incorrect in several respects. I would particularly draw your attention to the fact that our coverage does not provide unidentified trailer interchange coverage. Our policy period is twelve months at 23rd October 1990, the effective date for the addition of K. & R. Inc., and K. & R. Transportation, Inc., is 4th April 1991, which would be issued on the evidence of insurance form specimen enclosed. We will contact the Californian Broker requesting him to issue amended documents reflecting the above points.
