

My clients have authorized me to take whatever actions are necessary to make you stop making derogatory statements and to recover any damages resulting from them. Such actions would entail a lawsuit against you for restraining orders as well as damages, including punitive damages.

We trust that you do not wish to incur the expense and aggravation of litigation and will immediately comply with the demand to cease and desist from making any such statements. We have been authorized to withhold any action pending your response to this communication and our demands.
