

### 5-Year Limited Warranty

**WARRANTY:** **Cubitac Cabinetry** warrants its cabinetry to be free of defects in material and/or workmanship under normal residential usage to the original purchaser\* for as long as they own their home.

This warranty are only applicable to product used in residential applications within the United States and Canada and are not transferable to subsequent owners.

Our obligation under this warranty shall be limited to the repair or replacement of any part or parts that prove defective as determined by our review. These warranties do not cover the cost of installation, removal, subsequent damage, or transportation, regardless of who performs the work.

This warranty shall become void if **Cubitac Cabinetry** products are misused, abused, mishandled, improperly stored, changed, modified, or subjected to extreme temperatures or extreme moisture levels, acts of nature or the effects of normal wear and tear. These warranties do not apply to cabinetry ordered and purchased unassembled.

Naturally occurring variations are inherent in real wood products and should not be perceived as defects. These variations include but are not limited to variations in color, grain and texture, including color differences between and among wood panels and parts. Cabinet finishes darken or lighten over time due to sunlight, smoke, household cleaners and other environmental conditions. These are naturally occurring characteristics in wood products and are considered acceptable when within our product standards and commercial tolerance.

Variations also occur in **Cubitac Cabinetry** hand-wiped Glazes and Character Finish Packages. These variations in finishes should not be considered defects in workmanship or material, but are what give each piece a unique and authentic, hand-crafted look. Please consult our Glaze Finish and Character Finish Package Agreement, if applicable.

Painted face frames and other painted product may eventually have visible cracking around the joint areas. These variations are considered the natural characteristics of the material in relation to their environment and are not covered under these warranties.

**Cubitac Cabinetry** reserves the right to substitute discontinued product with the most similar styling, wood species, and color available at the time your claim is submitted.

These warranties are the exclusive warranties of **Cubitac Cabinetry** Cabinetry and are in lieu of all other warranties, expressed or implied, including the implied warranties of merchantability and fitness for a particular purpose.

These warranties give you specific legal rights. You may have other rights which vary from state to state.

To obtain consideration under this 5 Year warranty, first contact your authorized **Cubitac Cabinetry** Cabinetry dealer, who will arrange for an inspection. A dated sales receipt as proof of purchase is required to obtain benefits from these warranties. If a dealer is unavailable, please write to: Warranty Department, **Cubitac Cabinetry** Cabinetry at the address noted at the bottom of the page, with an explanation of the defect.

This warranty are effective on product manufactured on or after December 1, 2014. In keeping with our policy of continued product improvement, **Cubitac Cabinetry** Cabinetry reserves the right to change product specifications without notice. If the warranted product has been discontinued **Cubitac Cabinetry** normal operating procedures and policies apply to the administration of these warranties.

\*The limited warranty is transferable from the company that purchased the cabinetry to the original purchasing consumer. No other transfers of this limited warranty are permitted. For new construction, proof of new home purchase and date are required.

**DISCLAIMER:** **Cubitac Cabinetry**, has gone to great measures to design our white lines of cabinetry to be as free from imperfections as possible. You should be aware, however, that joints in the face frames and in certain accessories have a tendency to open up during shipment and installation. **Cubitac Cabinetry**, does not warrant its products against this. This tendency is more noticeable in painted finishes than in stained finishes. Touch up may be necessary on some jobs which feature our white cabinets, and this touch up is generally conducted by the person/s/ installing the job. For this reason, we offer a touchup paint and a putty powder that can be mixed with water to the consistency that best suits the installer.

Note: If this job is being purchased without installation the responsibility of touch up falls upon the purchaser. While the application of putty to opened seams and other areas may improve the cabinets appearance, the color, texture, and sheen of the putty will be inconsistent with those of the paint.

Neither **Cubitac Cabinetry**, nor any of its dealers can be held responsible for this inconsistency. When viewing a sampling of our white cabinetry, you may have noticed that the doors and sides of the cabinets feature a Satin finish, while the front frames feature a more flat finish. This intentional difference allows us to provide you with a greater degree of durability on the doors and sides than would be possible if they were painted. The surface materials on the doors and sides are much more resistant scratches, mars, chips, cracks, peeling, and yellowing than most paints available today. We bring these characteristics to your attention because the product sampling available to you may not provide you with an adequate idea of how an installed kitchen or bathroom vanity will appear. It is your responsibility to decide whether or not the natural characteristics of painted wood products will satisfy you.
