Some years ago, Mother Teresa offered, "I alone cannot change the world, but I can cast a stone across the waters to create many ripples." Though formed in 2012, it was in 2013 that The Joseph Fund, Inc. began re-investing resources into our Camden neighbors and neighborhoods. In five fast-moving years working together with YOU, our collective economic impact totals more than \$2.1 Million back into "Transforming Lives, Transforming Camden!"

By October 2018, more than 30% (188) of persons\* once homeless found permanent housing, 20% (123) found employment. Capacity enrollment of the Child Development Center was maintained because we gapped the shortfall of state funding for the before and after school programs. Youth Outreach secured a permanent home in East Camden able to accommodate growing programming demand and avoiding crippling move-in debt. There are many other examples of The Joseph Fund's stewardship adding to a rising tide of success in the city of Camden. Your ongoing contributions inspire self-determination, raise aspirations and lift the spirit of all persons who seek a Hand Up to attain their highest destiny. The fact that THEY do it, is why this transformation will last for generations. On their behalf, I say 'thanks!'

With so many budgetary challenges for our partner organizations, The Joseph Fund of Camden is fortunate to have measured a 14% growth in donations powered by strong new support, increased contributions in our two events (TJF 5K and Hand Up Gala) and, the establishment of The Michael J. and Joseph G. Procacci Scholarship Fund. Two important pillars supporting The Joseph Fund's success remain our extraordinary Trustee involvement and the establishment of a long-range endowment strategy.

I further wish to recognize the Halloran Philanthropies, especially Harry and Kay Halloran for a long-term, committed belief that continues to inspire the accomplishments you see on these subsequent pages.

Our approach to stewardship has been successful. It keeps us agile and efficient, extending a thriving mission that impacts the entire community (in and outside of Camden).

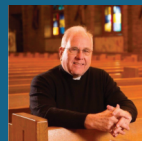

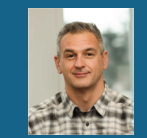
